# OTIS JEFFERSON - POLICY AND PLANNING CHAIRMAN REVISE BY-LAWS ADD

B-3 A DIRECTOR OR ASSISTANT DIRECTOR MAY BE REMOVED FROM OFFICE FOR FAILURE TO PERFORM THE DUTIES OF HIS OFFICE UPON RECEIPT OF A SIGNED PETITION BY AT LEAST ONE HALF OF THE CLUB REPRESENTATIVES IN THAT DIVISION. THE MISGA PRESIDENT SHALL HOLD A HEARING WITHIN 30 DAYS AT AN APPROPRIATE LOCATION IN SAID DIVISION. ATTENDING THE HEARING SHALL BE THE MISGA PRESIDENT, SECRETARY, THE LEGAL COUNSEL AND ALL CLUB REPRESENTATIVES, OR DESIGNEES, OF THAT DIVISION. AFTER ALL PARTIES HAVE HAD AN OPPORTUNITY TO PRESENT THEIR CASES, UPON AN AFFIRMATIVE VOTE OF THREE-QUARTERS OF CLUB REPRESENTATIVES OF THAT DIVISION FOR REMOVAL, THE DIRECTOR OR ASSISTANT DIRECTOR SHALL BE DEEMED REMOVED. THE DIVISION SHALL PROCEED TO FILL THE VACANCY ACCORDING TO ESTABLISHED POLICY.
