

Attendees: Howard Taylor, Tom Taylor, John Babyak, Dick Schwinger, Dave Woodward, Malcolm Peterson, Bob Turner, Jim Wilcox, Steve Neal, Jim Beisler, Byron Keadle, Ted Ifft, Charlie Fieldhouse, Pete Sorge, Ralph Starkey, Tom Tarpley, Lloyd Stimson and Errol Myers.

Call to Order – Howard Taylor opened the meeting at 10:00 A.M.

Opening Remarks - The MISGA President, Howard Taylor, welcomed everyone and introduced two guests, Dick Dale and Paul Keiser, a past president of MISGA. Howard thanked Byron Keadle for putting the Annual Report together. In 2010, there were 400 mixers compared to 367 in 2009. Total revenue to the clubs in 2010 was \$901,774 vs \$882,126 in 2009. Howard is concerned that some of the clubs are trading on the MISGA name, via MISGA-only memberships, etc. Howard has some MISGA History handbooks from 1975-1995 if anyone would like to have them.

Secretary's Report – The minutes of the September 14, 2010 meeting were previously distributed via e-mail and were published on the web site. A motion was made and seconded to accept the minutes as presented on the website. The minutes were accepted.

Treasurer's Report – A report was distributed. The third installment of the division allotments has been paid. All club dues are current and membership is down slightly. Howard said that he thought that there was a motion made last year that excess from this year's operating budget go into the prize pool for the Past Presidents and Two-man tournaments. Past minutes will be reviewed to try to find a reference. A budget for 2011 will be sent out via e-mail or at the March meeting.

Vice-President's Report – No Report

Division Director Reports

Division I – A report was distributed via e-mail. Weather conditions this year and a low number of sign-ups caused several mixers to be rescheduled or cancelled. Communication and no-shows were also a problem this year. Each club must have a written confirmation from other clubs before publishing their schedule and pro shop phone numbers should be provided for cancellations. Division I clubs will not schedule a mixer on the same date as a MISGA or Division I event. Garrison Lake, a former MISGA club, is in the evaluation process to re-join MISGA.

Division II – A report was distributed via e-mail. Tom Taylor reported that the division had a good year. A favorable report was given by the division for the acceptance of Fountainhead Country Club as a new Division II club. There is concern for the survival of the VFW golf club, they are down to 9 or 10 members and the maintenance of the club is being done by the MISGA members. The Musket Ridge golf course is owned by PNC Bank and is up for sale. Charlie Gailunas, the Assistant Division Director has resigned for health reasons.

Division III – A report was distributed via e-mail. Malcolm Peterson said that there is a communication problem with associate cancellations at mixers. Associates need to notify the host pro shop if they signed up for a mixer but do not plan to attend. Bert Bigelow will be the Division Director in 2011. Ralph Starkey will be the Assistant Division Director and will be the MISGA Vice-President in 2011. A discussion followed about which tees should be used by women in MISGA events. The division will set up a rotation of clubs to sponsor division qualifiers. An associate at the Division meeting was confused by the terms ABCD and Past Presidents Tournaments. He suggested that we clarify the literature announcing these events.

Division IV – A report was distributed via e-mail. Bob Turner said that the division results, number of mixers and number of participants, in 2010 were the same as in 2009. Jim Wilcox will be the Division Director in 2011 and Mike Urquhart will be the Assistant Director.

Division V – A report was distributed via e-mail. Steve Neal reported that the division clubs agreed that the program of designating exclusive dates for club mixers has worked well and they want to use the same procedure next year. The division now has a female member from Ocean Pines. She is primarily a nine-hole golfer and is mostly interested in the “Flings” but she will play in 18-hole mixers. There are two division clubs with problems, the Elks Club will continue in MISGA even though their membership has declined and the pro at the Beach Club, which is up for sale, thinks that the primary candidate to buy the club would want to continue in MISGA. Jim Beisler was introduced as the new Assistant Division Director. Steve commented about some of the mixer no-shows and stressed the importance of good communication.

Division VI - A report was distributed via e-mail. Byron Keadle said that the new Assistant Division Director is Carl Lazar from Walden Golf Club. About thirty associates have left the Patuxent Greens club and have joined the Cross Creek Golf Club in Beltsville, MD. Patuxent now has 12-15 members and may not be a viable MISGA club after 2011. Cross Creek is being considered for MISGA membership and if approved, they will use the 2011 mixer schedule for Patuxent Greens. The remaining Patuxent Greens members will be invited to all Cross Creek mixers.

Committee Reports

Associates – Charlie Fieldhouse submitted reports via e-mail. In 2010, two clubs left MISGA and one club, Nassawango, rejoined. There is a revised Deceased Report and the club reps will be required to fill out this report when an associate passes. Charlie asked that he receive a list of reps, asst reps, etc. in order to update the Associates Reports.

Audit – Gary Sorrell submitted a report via e-mail. Gary reviewed the 2010 Spring Fling at Williamsburg. There was a shortage of \$279.12 which was covered by the starting balance from the previous year. There is a carryover amount of \$129.90 for use in 2011. For the ABCD(Past Presidents) Tournament at Chartwell, an overage of \$26.00 was deposited in the MISGA account.

Legal – Jim Ewalt was not at the meeting.

Events – Pete Sorge said that he had fifty people at each of the two Fall Frolics and that he received comments that people liked the small groups. The hotel at Amelia Island has been sold to OMNI International. He has received a preliminary contract but now instead of one price per person/couple, they are itemizing for rooms, golf, admin fees, tips, etc. the first iteration that they sent was 65% higher and all rooms at the hotel for the days we want are booked. Fripp is always good, friendly and they welcome us. Pete is looking at other venues. One problem is that some venues do not want to give us a shotgun start without 100 golfers. Pete said that he does not get reports from the other frolics and flings and would like to have them. The Spring Fling is scheduled at Williamsburg, VA on May 17-19, 2011. Dick Dale said that we have good courses scheduled; The Woods course at Kingsmill on the 17th, Golden Horseshoe on the 18th and Ford's Colony on the 19th. The cost will be; couple(two golfers) \$658, couple(1 golfer) \$380 and single golfer \$329. In the past few years, a number of people had access to timeshares and others chose to use less expensive hotels. So, this year, we will not be involved in arranging lodging. In an effort to keep the costs down, there will be only one meal provided. A discussion about contracts and costs followed. Dave Woodward commented about the non-golfing ladies and how well these MISGA events are made available to them.

Historian – The position is vacant.

Membership – Ralph Starkey reported that Fountainhead has applied to join MISGA. They have 42 members on the list for MISGA and have 200 senior members at the club. The club meets all of the eligibility requirements and the committee met and agreed to accept them. There was a motion to accept Fountainhead Country Club into MISGA. The motion was approved. The next club for entry into MISGA is Garrison Lake. The club was a MISGA member in the past. The club dropped out of MISGA, the course was sold and purchased by the state. All of the paperwork has been completed and they have 28 members signed up. There was a motion to accept Garrison Lake. The motion was approved. Cross Creek is being evaluated for membership into MISGA. It was agreed that as soon as the report from the evaluation committee is complete, the board will vote on acceptance via e-mail. Howard Taylor said that he is concerned about is trading on the MISGA name. Cross Creek is planning a MISGA-only membership as one of its membership options. This is a Division VI club and Ralph Starkey is on the evaluation committee along with Larry Lewis from Division II and Jim Wilcox from Division IV. A discussion about Cross Creek and Patuxent Green membership followed.

MISGAGRAM – Byron Keadle submitted a report via e-mail. The next MISGAGRAM would be available by mid-December. Byron tried to limit the size of the document to 3 megabytes. He suggested that the division training seminars should include a tutorial on how to access the website and download the MISGAGRAM. A discussion about the content and distribution of the MISGAGRAM followed.

Policy and Planning – Bob Turner submitted a report via e-mail. He suggested three changes to the guidelines. The first, re MISGAGRAM Committee, Section VI, deleted Paragraphs 3, 4 and 5. Another change had to do with sending event reports to the Auditor instead of the Treasurer. The third had to do with roster maintenance and the MISGAGRAM. There was a motion to accept the guideline changes. The motion passed.

Rules and Handicap – Dick Crone was not at the meeting but he submitted a report via e-mail. The percentages of posted scores for the 2010 State Tournaments were very good. In 2011, he will again monitor the posting of scores for determining eligibility for participation in 2012. USGA re-licensing will be required by January 1, 2012 in order that clubs may issue handicap indexes. Another discussion about playing from different tees followed.

Tournament Chairman – A report was submitted via e-mail. Lloyd Stimson thanked Errol Myers for the website help that he has provided. Tournament information has been consolidated into one section, Championship Tournament Information. The Tournament Results and History subsection has been updated and reformatted. A schedule of tournaments and Division Qualifiers is also on the website. At the last meeting, the Board identified three areas of concern with the MISGA Championship Tournament Guidelines. The first was the Tournament Interruption Procedure. That couldn't be resolved so Lloyd put down TBD (to be determined) in order to expedite approval of the Guidelines. Two other items that were resolved were entry fees and golf cart requirements. After some discussion, there was a motion to accept the recommendations of the Tournament Chairman. This motion approved the use of the MISGA Championship Tournament Guidelines for operational use. The motion was passed.

Past Presidents Ad Hoc – Tom Tarpley had nothing to report.

Web – Errol Myers said that he is updating the website. He would like the updates to the leadership roster and the schedule of meetings for 2011.

New Business

Associates Roster – Charlie Fieldhouse recommended that we change our rosters to flag the fact that we have female associates. This would be accomplished by making an entry in a column of the roster indicating “F” for female. A question was raised about where a female

MISGA member would play at the flings and frolics. It was suggested that they could play with the MISGA members or with the women, their choice. A motion was made to approve the recommended change to the roster. The motion was passed.

Cheating – There was another discussion about cheating. Tom Taylor talked about a particular associate who blatantly cheats. The club reps invited the associate in to discuss the problem, but he would not show up. They want him out of MISGA. The board is the only venue to dismiss/expel a member. This topic was put off until the next meeting so that have MISGA Counsel take a look at this. A discussion about the associate followed.

Women’s Tees at State Tournaents. – John Babyak suggested that the Tournament Guidelines should have a provision to set a suggested yardage for the women’s tees at State Tournaments.

Chartwell – Jim Wilcox raised a question about Chartwell C.C. being moved to Division II or IV. No resolution.

New Officers – Howard’s last duty as MISGA President was to turn over the gavel to the new President, Tom Taylor. Tom said that he lost everything on his computer and is in the process of putting it all back. He thanked everyone for remaining in their positions as committee chairmen, etc. for 2011. Earl Gayler will be rejoining us as the MISGA Historian. The next board meeting will be held on Monday March 21st at the University of Maryland. Coffee and doughnuts at 9:30, the meeting at 10:00 and golf at 12:30. The Annual Meeting will be on Monday April 11th at Prospect Bay. There will be a Board Meeting on September 13th but the location has not yet been selected. He is considering Heritage Hills in York, PA. as well as Carroll Valley. The date of a December meeting is undecided. For the coming year, Tom would like to stress leadership at the clubs and to try to increase participation at the club level. He would like to try to make it more inviting for the lower handicap players. This may be accomplished by flighting so low handicappers can play with their peers.

Election of a Vice-President. - Ralph Starkey from Division III was nominated and elected.

Wrap-up – There was a motion to adjourn. The meeting was adjourned at 12:50 P.M.

No shows were a problem this year. Each club must have a written confirmation from the other clubs before publishing their schedule. Include pro shop phone numbers on the schedule for the visited club so your associates have a ready reference to use for any emergency cancelations after the Rep sends the sign up roster to the host club.

The low number of players sign up also caused some mixers to be canceled. The home club Reps will call all visiting clubs Reps and proshops at least 48 hours prior to the mixer and inform them the mixer is canceled.

Division 1 clubs will not schedule a mixer on the same date as MISGA or Division 1 wide events. Each club will schedule at least one home and away with all Division 1 clubs and at least one club from both Division III and Division V.

DIVISION III DIRECTOR'S REPORT

DECEMBER 7, 2010

Division III had its fall organization meeting on November 30. Representatives were generally pleased about the results of this year's mixers. Due to weather and other conflicts, a few mixers were poorly attended, even though associates had signed up to play. This is particularly stressful for the Club Rep. for Harbourtowne, given that the Harbourtowne pro shop is not as actively engaged in the process as are other clubs. The representatives agreed to stress to associates the imperative of notifying the pro shop when they are not going to attend a mixer for which they had signed up.

With regard to the MISGA-wide events, there was a discussion led by the Director as to the lack of enthusiasm for Division III qualifiers to play in the MISGA ABCD and Two-Man. Reasons given including (1) "filling out the field" by the qualifier hosting site's pro shop and (2) the cost of the MISGA-wide events. It was agreed that in 2011, the associates playing in the qualifiers would be required to have paid for the MISGA-wide event within one week of the qualifiers; associates would be encouraged to bring checks with them to the qualifiers to pay at that time, thus negating the need for mailing in their checks to the tournament director for Division III. There was unhappiness among a few reps and assistant reps as to the challenge presented to qualifiers who were unfamiliar with the MISGA-wide hosting sites. They preferred to have MISGA schedule these tournaments at sites where qualifiers could play in advance of the tournament date. The discussion clarified for these reps/asst reps why this would restrict the number of future willing venues.

There was agreement that a "rota" would be established of Division III clubs which would host the qualifying tournaments, so that clubs would know well in advance what year would be their turn. The discussion on the Pro-Am siting was postponed until the Director had the opportunity to engage with the Directors of Division I and V on holding a joint Pro-Am in 2011.

One relatively new MISGA associate was present at the meeting and pointed out to the others that the terms: "ABCD" and "Past Presidents" had confused him. (He thought that a team of players with A,B,C, & D handicaps had to be assembled in order to play.) He suggested that we take a careful look at our literature announcing the events to ensure clarity.

The Division Director for 2011 will be Bert Bigelow. The Assistant Director will be Ralph Starkey. Ralph also agreed to serve as Division III's candidate for MISGA Vice President in 2011. Mal Peterson will serve as Division III Tournament Director.

2. It was announced at the meeting that Mike Urquhart was elected as the incoming Assistant Director as Jim Wilcox becomes Director. And Bob Turner becomes Chair of Policy and Planning.

Division V has signed up its first female member, she is from Ocean Pines. The proposed MISGA Reps at Cross Creek are experienced in the ways of MISGA, having served in several capacities at Patuxent Greens for many years. Cross Creek's General Manager Brian Boltz was employed by Indian Spring Country Club for 22 years until it closed for real estate development. He is very knowledgeable on MISGA activity.

Plans for 2011

Informing Membership regarding Rules & Handicap Issues

-- In the MISGAgram - Rules Articles

In 2011, the Committee Chairman intends to continue to prepare interesting real-life rules-related golfing situations. If there are no interesting real-life situations for a while, the Chairman will revert to using one of the basic rules reminder articles from former President Sam Hall's 2001 Rules and Handicaps Project.

Monitoring of Score Posting of Championship Tournament Scores

The Chairman's monitoring of the score postings of the more than 200 Associates participating in the 2010 Championships revealed that 88 percent of the ABCD Championship players posted their scores, and 92 percent of the Associates in the 2-Man Team Championships posted their scores.

Because these percentages were very good and in line with the numbers for the last two years, the Chairman did not recommend that the Board apply the tournament ineligibility policy for the 2011 Championships, and the Board voted accordingly, to not apply the policy for 2011.

In 2011, the Chairman will again check the score postings of the Associates participating in the MISGA Championships, and will submit the results to the Championship Tournament Committees, in accordance with the Revised Tournament Policy Guidelines, for the Committees' possible use in determining eligibility for participants in the 2012 Championships.

USGA Club Licensing Program -- Relicensing Required by January 1, 2012

In the fall of 2004, the USGA directed the State Golf Associations to implement a program in their States to license clubs with authority to issue USGA handicap indexes. That requirement began January 1, 2006.

By that date, all MISGA clubs had completed the steps to be licensed by their state golf associations, including the verification of an active handicap committee by the club handicap chairman, the taking of a handicap seminar and passing a handicap test (at a live seminar and testing by the USGA or state association, or via the USGA's online seminar and test).

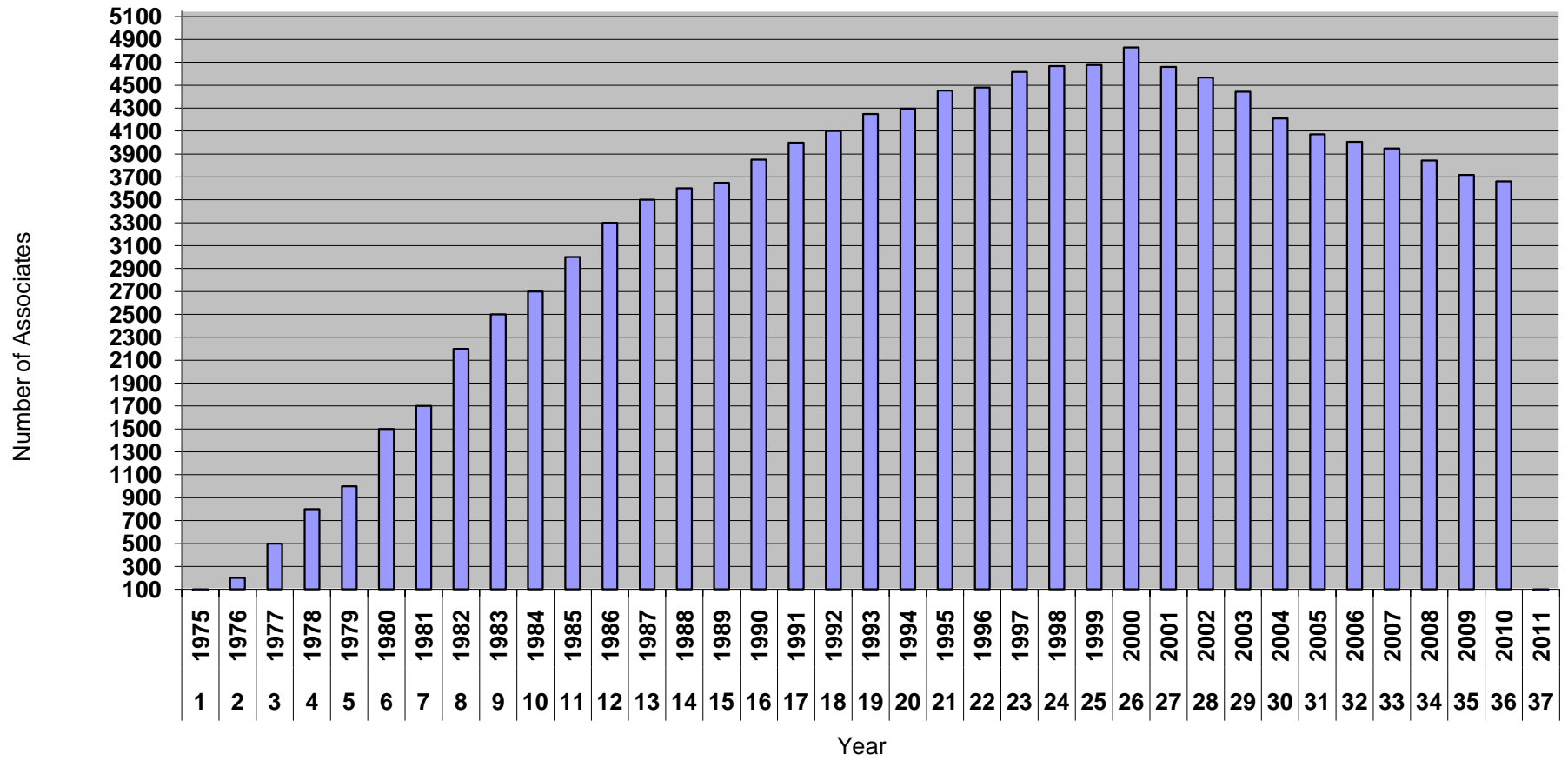
The USGA is now requiring that all clubs be relicensed to issue handicap indexes by January 1, 2012. In early 2011, the state golf associations will be notifying the clubs in their states that by the end of 2011, the clubs must complete the steps to be relicensed to issue handicap indexes.

In 2011, the Handicap Chairman will work with the Division Handicap Chairmen to ensure that all MISGA clubs take the necessary steps in 2011 to be relicensed to issue handicap indexes in 2012.

MISGAGRAM Editor Report
MISGA Board Meeting – 12/7/2010

The next MISGAGRAM, Volume 103, will be published in mid-December. The December MISGAGRAM will be the largest yet to be put on the internet. It has pictures from both Fall Frolics. Those with dial-up access should initiate a download (Rt. Click, Save Target As) at bed-time and let it run until it's finished.

There are some associates who are not getting to read the MISGAGRAM and who probably aren't accessing the misga.org web site, either. Some have only a rudimentary knowledge of how to send and receive email, but not how to open attachments. Many are still accessing the internet through dial-up connections, much too slow to download the MISGAGRAM, which runs to 3 Megabytes or more. The plan was to have each club rep print a copy and hang on their bulletin boards for those without web access or knowledge. I suggest that Divisions include in their training seminars a tutorial on how to acquire Adobe Reader, how to download documents from the web site, and how to use the Adobe Reader controls for better viewing, including the Zoom controls.

Quote from the Proposal to Stop Printing the MISGAGRAM:

5. What about those who don't have email or access to the web? In that case, the Club Rep can put the MISGAGRAM PDF file on a CD and take it to the local FedEx Kinko's. There, he can have copies printed directly from the CD for \$0.96 a copy for an eight-page MISGAGRAM, or \$1.43 for a 12-page 'gram. Ah, but color is out of reach at \$11.35 for 12-page 'gram. The only reasonable way to see color is to view it from the web site. Or, the Rep can print it on his own printer (in color) and give (or sell) it to the technically challenged associates. Another option: Print a copy and post it on the bulletin board.


We repeat the printing suggestions for those Club Reps who may wish to post a copy on his club's senior bulletin board:

Printing the MISGAGRAM

For those who wish to print a copy of the MISGAGRAM, the following suggestions are offered.

1. Use 96 Bright paper of 24 lb Weight.
2. If your printer supports 2-sided printing, then set binding option to long side, left (this causes the print to be upright on both sides; the 24 lb paper greatly reduces ink jet bleed-thru).
3. Use a three-hole punch to prepare the MISGAGRAM for inserting in a three-ring binder, or staple sheets together in upper left corner.
