Minutes - MISGA Meeting March 21, 2011 Revised April 16, 2011

**Attendees:** Howard Taylor, Tom Taylor, John Babyak, Dick Schwinger, Bert Bigelow, Jim Wilcox, Mike Urquhart, Steve Neal, Byron Keadle, Ted Ifft, Carl Lazar, Charlie Fieldhouse, Gary Sorrell, Jim Ewalt, Pete Sorge, Ralph Starkey, Tom Tarpley, Dick Crone, Errol Myers.

**Call to Order –** Tom Taylor opened the meeting at 10:00 A.M.

**Opening Remarks -** The MISGA President, Tom Taylor, welcomed everyone and thanked Ted Ifft for making the arrangements for the meeting. Ted discussed the arrangements for lunch and golf. Tom then had all of the Board introduce themselves and state their positions on the Board. Since the last meeting, Cross Creek has been accepted into Division VI of MISGA via an e-mail vote. MISGA did address the allegation of cheating by a member of Piney Branch. Pewter Trays have been received and will be available to be distributed at the Annual Meeting. The E-mail Distribution System is working very well thanks to Byron Keadle. We will use that system for the advertising flyers prior to the Annual Meeting. The envelopes and posters will be available for the clubs at that meeting. We are asking the Division Directors to find out who will be attending that meeting. This info should be given to Bert Bigelow by the 5<sup>th</sup> of April.

**Secretary's Report** – The minutes of the December 7, 2010 meeting were previously distributed via e-mail and were published on the web site. A motion was made and seconded to accept the minutes as presented on the website. The minutes were accepted.

**Treasurer's Report** – A report was distributed. The reports showed the Actual vs. Budget for 2010 and the Proposed Budget for 2011. The allotments for the divisions for 2011 were also reported. There was some discussion about +/- entries in the report. There were two clubs that did not pay their club dues for 2010. It was pointed out that MISGA does not have a penalty in place for clubs that do not pay their dues. It was proposed that we deduct any unpaid dues from the allotments to the division. The next payment for the divisions is in June and the unpaid dues should be deducted from those allotments and let the divisions worry about it. Tom pointed out that we had a 2010 surplus of \$1127. That money should be transferred to the Tournament Chairman to be divided for prize money for the State Tournaments in 2011. Charlie Fieldhouse proposed that a motion should be made that unpaid club dues would be subtracted from the division allotments. The motion was made and approved. There was a motion to accept the Treasurer's Report. The motion was approved.

Vice-President's Report - No Report

### **Division Director Reports**

**Division I** – A report was distributed via e-mail. There are 65 golfers and 26 non-golfers signed up for the Spring Fling in Williamsburg, VA. There is still room for additional golfers but there is a mid-April cut-off date for registering.

**Division II** – A report was distributed via e-mail. The division will pay 50% of the entry fee to attend the State Tournaments for the overall winners of the Division ABCD and Two-man Tournaments. The Summer Frolic will be held at Carroll Valley, which has been renovated, on September 14 & 15.

**Division III –** A report would be distributed via e-mail.

**Division IV** – A report was distributed via e-mail. Leisure World has suggested that visiting club reps collect all of the money for their clubs at mixers. Division IV will not do that and the division thinks that Leisure World will change their minds about this.

**Division V** – A report was distributed via e-mail. The Beach Club is no longer a member of MISGA. The division has voted to not implement an age plus handicap adjustment to allow some players to play from different tees.

**Division VI -** A report was distributed via e-mail. Ted Ifft said that there is a problem at the University of Maryland Golf Course with high food costs. The dining room is run by the university dining service and they dictate the costs.

### Committee Reports

**Associates** – Charlie Fieldhouse submitted reports via e-mail. He deleted the Beach Club which dropped out of MISGA. Rosters are due on June 1<sup>st</sup>. He asked that rosters be sent in via computer, not hand-written.

**Audit** – Gary Sorrell submitted a report via e-mail. Gary reported that the information for the 2010 Summer Frolic was audited, with no problems. He does not have any information on the Fall Frolics.

**Legal** – Jim Ewalt said that no one is taking legal action against MISGA and that we are not taking legal action against anyone.

**Events** – Pete Sorge discussed the situation at Tantallon. The club rep has worked really hard at that club for six years. He created posters for all of our events and posted them at the club. The club told him that they wanted to post club events themselves. Since then, the club has informed him that he cannot send out e-mails to any member of the club regarding MISGA events unless the e-mails are pre-approved by the club management. The club may be concerned about a defection of members, as happened at Patuxent Greens. Legally, they can't stop e-mails but they can fail to cooperate with MISGA. The club rep will resign from the club on April 30<sup>th</sup> after 30 years. Byron Keadle said that his club has the same management company and they want to take over the clubs Senior Treasury function and have the money pass through their books and they will reallocate it. A discussion followed. The Fall Frolics will be held on October 30-November 4 and November 6-11. Pete has talked to someone at the Village by the Sea at Jekyll Island. We would not get a shotgun start but Pete felt that could work. So Jekyll Island might be the second venue. Pete also went to Seabrook. They tore down the old convention center and built a new clubhouse. We are definitely going to Seabrook the first week, he is just waiting for a revised contract. The second event may be at Jekyll or as back-ups, Fripp Island or Pinehurst. We went to Amelia last year which was fantastic. They were bought out by OMNI and they sent Pete a new proposal for this year but the cost has increased by 50%. Pete has two gift certificates for Amelia Island, 3 days, two nights and two rounds of golf per person. He is looking for suggestions about what to do with these. Last year they were raffled off at the Spring Frolic. It was decided to raffle one certificate at the Annual Reps Meeting and one at the Spring Frolic.

**Historian** – The position is vacant.

**Membership** – Ralph Starkey didn't have a membership report. He did want to discuss the Caroline Country Club. The club is cash-poor and they have looked into ways of staying afloat. They are looking at selling the club, members buying equity shares or opening it up for private play. It appears that the club will remain open for 2011.

**MISGAGRAM** – Byron Keadle submitted a report via e-mail. When we mailed out the MISGAGRAM, we also sent a copy to the GM and Pros at all of the clubs. Now, with the MISGAGRAM online, it is the responsibility of the club rep to provide the GM and Pro with the URL to access the MISGAGRAM.

**PP AD HOC** – Tom Tarpley submitted a report. Tom reported that Byron Keadle had received the Green Jacket Award for his contributions to MISGA. This award was presented to Byron at Manor Country Club as part of the Division IV Christmas Luncheon. The report detailed some of Byron's contributions.

**Policy and Planning** – Bob Turner was not at the meeting, no report.

**Rules and Handicap** – Dick Crone submitted a report via e-mail. The USGA requires that all clubs must be re-licensed in 2011 to issue handicap indexes. USGA rules will not be revised in 2011. The R & H Chairman will monitor score posting for the State Tournaments again in 2011. Tantallon owners are sending e-mails to a number of MISGA members for every event held at their two clubs. Concerning Special Tees for different reasons, the Handicap manual provides a way to use course yardage to determine course rating and slope. Ted lfft said that he is going to try to get the Free State schedule to try to eliminate conflicts with dates.

**Tournament Chairman** – Lloyd Stimson was not at the meeting. He did submit a report via email.

**Web** – Errol Myers submitted a report via e-mail. He is up-to-date with personal info on the website. For the Annual Club Reps Meeting, he will be providing cards for the club reps to verify their information and to provide starting times, fees, etc.

### **Old Business**

**Recruitment and Advertisement** – Tom Taylor sent out the "What's all this about MISGA?" He asked Byron to send copies of the flyer and directions to print this out before the Annual Meeting. At the Annual Meeting, we will be giving out the posters and envelopes. These will be given to the Directors and they will see to it that they get to their clubs.

**Cheating** – A letter was sent, with the advice of counsel, to the rep at Piney Branch. We turned the problem back to Piney Branch to be resolved.

### New Business

**Annual Meeting** – Bert Bigelow handed out a schedule for the Annual Meeting, Prospect Bay will have aerification on March 28<sup>th</sup>, but the course should be in good shape for the meeting.

**Low Handicap Players** –Some players with low handicaps do not play in MISGA because a round takes too long. They feel that if a player's ball will not count in the team score, that player should pick up his ball. A discussion of slow play followed.

**Dues at Different Clubs.** – Hobbits Glen and Fairway Hills are both in Columbia, MD. There are about 30 associates that are members of both clubs and a couple of them feel that they should only pay MISGA dues once even though they are in two different divisions. There are 42 people who belong to more than one club. A motion was made that we charge each member of a MISGA club, the MISGA dues at that club. The motion was seconded and approved. Jim Ewalt pointed out that to be a MISGA associate, a person must belong to a club and pay MISGA dues. He pointed out that the guidelines state that per capita dues is to be collected at each club. He suggested that we put something in the guidelines to clarify the issue.

**Annual Meeting Discussions** – Tom Taylor asked that all committee chairmen be prepared to give a report. Director reports will not be required.

**Florida Member** – Can someone in Florida remain active in MISGA? A former member may take part in a mixer on a space available basis.

**Rotation of Clubs.** – The rotation of clubs for State Tournaments policy expires in September 2011. We will have to discuss this at the September meeting.

Wrap-up – The next meeting is September 13<sup>th</sup> at Carroll Valley. There was a motion to adjourn. The meeting was adjourned at 11:50 P.M.

### Plans for 2011

### USGA Club Licensing Program -- Relicensing Required by January 1, 2012

The USGA is now requiring that all clubs be relicensed to issue handicap indexes by January 1, 2012. In early 2011, the state golf associations (or the PGA Mid-Atlantic Golf Assn. for some state associations) informed the clubs in their states that by the end of 2011, the clubs must complete the steps to be relicensed to issue handicap indexes.

In 2011, the Handicap Chairman will work with the Division Handicap Chairmen to ensure that all MISGA clubs take the necessary steps in 2011 to be relicensed to issue handicap indexes in 2012.

### Monitoring of Score Posting of Championship Tournament Scores

In 2011, the Chairman will again check the score postings of the Associates participating in the MISGA Championships, and will submit the results to the Championship Tournament Committees, in accordance with the Revised Tournament Policy Guidelines, for the Committees' possible use in determining eligibility for participants in the 2012 Championships.

### Informing Membership regarding Rules & Handicap Issues

-- Rules Articles - In the MISGAgram

In 2011, the Committee Chairman intends to continue to prepare interesting real-life rules-related golfing situations. The USGA Rules will be revised in 2012.

### **General Coordination with Division Handicap Chairmen**

The Chairman will coordinate with the Division Handicap Chairmen regarding issues requiring attention.

### **Recent Committee Activity**

On March 19, the Chairman sent to MISGAgram Chairman Keadle an email (to be sent to the Club Reps via the MISGA Email Distribution System), notifying the club reps that the USGA is now requiring that all clubs be relicensed to issue handicap indexes by January 1, 2012, that their state golf association (or the PGA Mid-Atlantic Golf Assn. for some state associations) have informed their clubs of the relicensing requirement, and that the club reps may want to monitor their clubs' relicensing activities to ensure that their club is relicensed to issue handicap indexes in 2012.

# Printing the MISGAGRAM

For those who wish to print a copy of the MISGAGRAM, the following suggestions are offered.

- 1. Use 96 Bright paper of 24 lb Weight.
- 2. If your printer supports 2-sided printing, then set binding option to long side, left (this causes the print to be upright on both sides; the 24 lb paper greatly reduces ink jet bleed-thru).
- 3. Use a three-hole punch to prepare the MISGAGRAM for inserting in a three-ring binder, or staple sheets together in upper left corner.

# 2. MISGA Championship Tournament Flyers

The two MCT*flyers* contain detailed and relevant information involving MISGA's two championship tournaments (*Past Presidents & 2-Man Team*). They also provide Division Tournament Chairmen (DTC) with instructions for preparing and submitting Division *Entry Forms* and *Entry Fee Checks* to the host Club Tournament Coordinator.

a. The 2-Man Team flyer has been posted on the MISGA website.

b. After the joint planning meeting (MISGA and Host Club officials) has finalized the dynamics of the tournament, the Past Presidents (ABCD) **flyer** will be posted on the MISGA website.

# 3. MISGA Championship Tournament Entry Forms

In late May or early June, DTC will be provided with a standardized **Entry Form** for both the *Past Presidents (ABCD)* and *2-Man Team* tournaments. Each form will include specific instructions for completing and submitting the form to the host clubs. The forms have been designed so the DTC can keyboard entries directly onto the forms.

# 5. MISGA Championship Tournament Guidelines

The MCT Guidelines have been revised (revision #1 - Jan. 3, 2011) to include the USGA rules governing women competing with men in golfing events. The revision provides specific guidance regarding women's tee marker placements during the Past Presidents (ABCD) and 2-Man Team Championship Tournaments.

"Women finalists will be allowed the option of playing from the ladies' front (red) tees or the seniors' forward (gold) tees with the appropriate handicap allocation adjustment."

Basic USGA guidance states that women will receive a number of strokes equal to the difference between their tee marker "course rating" and that of the men's tee marker "course rating." (refer to Section 9-3, c of The USGA Handicap System Manual) Below is a sampling of

"course ratings" with their "appropriate handicap allocation adjustments" at MISGA golf courses. (.5 or more is rounded upward)
