Secretary's Report – The minutes of the December 6, 2011 Board Meeting were published on the web site. A motion was made and seconded to accept the minutes as presented on the website. The minutes were accepted.

Treasurer's Report – Dick Schwinger had four things to talk about. All bills are paid, no bills outstanding. He has received Div III's club dues. The clubs are supposed to send the \$50 to the Division and the Division will send him one check. He presented the Actual Expenses vs. 2011 Budget, The Proposed Budget for 2012 and the Actual Allotments for 2012. The Proposed Budget was voted on and approved. The Actual Allotments were also voted on and approved.

Division Director's Reports

Division I – Howard Taylor submitted a report via e-mail. Shawnee is under new management and there are two new reps. Bob Burd is the new rep at Shawnee. John Kennedy is the rep at Sussex Pines. He introduced Joe Bailey who is the Div I DAC. There is a problem with one associate from Wild Quail who has a conflict with the Delaware Amateur qualifier and a Div I and Div III qualifier. It was decided that he could skip the Div qualifier. Ralph Starkey made a comment about Williamsburg. They have room for more players but they do have about seventy-five signed up.

Division II – Tom Taylor submitted a report via e-mail. The plans for the Summer Frolic are still not solidified, they don't have a venue as yet.

Division III – Bert Bigelow submitted a report via e-mail. The Easton club has been sold. The new owners have spent some money making improvements. Hunters Oak was sold. He doesn't know what their status will be. Their pro has left the club.

Division IV – A report was submitted via e-mail. Membership in the division is stable, the membership at Montgomery C.C. went up. The division had a discussion about what tees that they would be playing. One club is saying that if your handicap is 30 or greater, you must play from the forward tees. At Kenwood, we will be playing from the forward tees but we will have an option for players to move back to a different set of tees with two strokes added to the handicap. Gary Manion mentioned that the Intercounty Connector is a good way to get to the courses in Div IV. There are four clubs that are enforcing a $4\frac{1}{2}$ hour time for mixers otherwise your team is not eligible for prize money.

Division V – Jim Beisler submitted a report via e-mail. Jim introduced the new Asst Div Director, Mike Mason. Ocean Pines has had some serious problems with its golf course. They are planning to redo nine greens this Spring and the remaining nine holes in the Fall. Unfortunately, they didn't take into account that the State of Maryland requires permits to do this.

Division VI – Ted Ifft submitted a report via e-mail. Compass Pointe has about forty members. Ft. Meade is closing, probably in May. Many of their members have gone to Compass Pointe. The club intends to stay in MISGA but will only schedule away mixers.

Committee Chairmen Reports

Associates – Charlie Fieldhouse was not at the meeting. He did submit a report. It was pointed out that he has a report for deceased associates but if you go to the MISGA website, you can't find the report. It turns out that it is listed under club rep info. It was suggested that the form be included in the FORMS section of the website.

Audit – Jim Wilcox submitted a report via email. The MISGA 2-man Final was not auditable because the host did not submit any receipts. It is vital that all event sponsors be reminded of the requirement to submit all receipts, checks and notes for the events. All other events were audited correctly.

Legal – Jim Ewalt reported that no one is being charged with anything, we are not charging anyone with anything and no one is in jail.

Events – Pete Sorge said that we are trying to work out something with Heritage Hills for the Summer Frolic. We will also consider Cacapon. Pete is still deciding whether to have one or two events for the Fall Frolic. We have about 50 or 60 people at each event but people are saying that they like the smaller groups. He has a contract with Fripp Island but hasn't executed it yet. There are some points in it that he wants changed. He is also considering Little River but those are all two bedroom units and they are only offering tee times which are not acceptable. He has considered other venues. Sea Trail is in bankruptcy again. He would like some more participation at the events from the Board.

Historian – Earl Gaylor was not at the meeting.

Membership – Tom Taylor reported that we have lost four clubs, Nassawango, the VFW, Ft. Meade and Hunters Oak. Ft. Meade will still be operating this year. There are two other clubs that are in trouble, the Elks Club and Wakefield Valley. Since 2004, we have picked up 16 clubs but we have lost 644 members.

Misgagram – Byron Keadle said that he talked with Dick Dale and Dick is not getting any communication about the availability of the Misgagram on the website. The reason is that his club rep is not interested in forwarding the info and he won't do it. Byron belongs to two clubs but he did not get any notice about the Misgagram. He contacted the club reps and eventually the notices came out. He would suggest that at the Spring training seminars, we emphasize to the club reps that forwarding info is part of their job. A discussion about emails and distribution followed.

Policy & Planning - Bob Turner was not at the meeting and had no report.

PP AD HOC – Tom Tarpley said that he put out a notice that Past Presidents have been asked to list at least 3 associates that deserve special acknowledgement for service. He would like to see a certificate given to these individuals for a job well done. It was suggested that we might give a MISGA coffee mug instead of a certificate. Speaking of past presidents, Sam Hall has metastatic cancer, and is undergoing chemo.

Rules and Handicap – Dick Crone said that he hoped all clubs have been re-licensed to give out handicaps. We will have many events played from multiple tee boxes so we sent a long email how to calculate the different handicaps. He will send to the club reps, through the Email Distribution System, a shortened version of the previous email on multiple tees. He will consider a version for possible posting on the website. He explained three of the more important rules changes made by the USGA and the R&A for 2012-2015.

Web – Errol Myers said that he needs the club reps to update the club info, like club fees and tee times. If clubs want to suggest the ICC for travel, they should supply that info.

Tournament Chairman – Lloyd Stimson submitted a report via e-mail. He has scheduled orientation meetings with the tournament committees at each club hosting the two 2012 MISGA Championship Tournaments (MCTs). The purpose of the meetings is to discuss the tournament management and coordination activities and review the associated documents. He reminded the Board that the size of the field for the two MCTs has been reduced from 128 to 100 finalists. Hopefully, this reduction will result in a shorter playing time. Although he is no longer restricted to selecting host clubs from within a 50 mile limit of the Bay Bridge for the MCTs, he asked consideration be given to the possible elimination of the division rotation schedule as well. This would increase flexibility for scheduling the MCTs at MISGA's higher quality clubs and at a more centralized locations within Maryland. It was questioned whether or not such action would require a by-law change. Stimson offered to investigate the requirement and report at the September Board meeting. The 50 mile limit of the Bay Bridge had eliminated all Div 5 clubs from hosting a MCT. There was a discussion about blended tees.

Non-MISGA Clubs for Tournaments – The question was raised about using non-MISGA clubs for tournaments but it was pointed out the by-laws require MISGA clubs only.

Wrap-up – The next meeting will be held on April 9, 2012 at Prospect Bay. Coffee and donuts at 8:30 AM and a meeting at 9:30 AM. A plated lunch, chicken cordon bleu or roast beef, at \$17 will be served at 11:00 and optional golf will be at 12:00. The cost will be \$20 for golf and \$5 for prize money. The club would like to know how any people will be there. Ralph thanked Gary Sorrell, moving to Indianapolis, for the outstanding job he has done for MISGA.

MISGA BOARD MEETING March 20, 2012 Hobbits Glen Golf Club Division IV Report

Division IV held its spring meeting and training seminar on March 15^{th} at Norbeck Country Club. There were 26 reps and assistant reps in attendance. Weather was in the 70's.

Information was shared on all of the MISGA tournaments for the year. Our Division IV championships will be held as follows:

ABCD: Bretton Woods, June 11 2-Man: Montgomery CC, June 25

Our Division IV Pro-Am will be held at Leisure World on August 27.

Clubs reported on numerous improvements to club facilities and golf courses. Membership appears to be stable for the year.

Most clubs reported that they are enforcing a 4 ½ hour rule for completion of rounds in mixers. Experience has been good, with very few disqualifications.

There was also discussion of what tees were being used at the different clubs, and the USGA/PGA "Tee It Forward" initiative. Some clubs allow or require certain players to play from forward tees if their age/handicap exceeds a certain level. Some others use blended tees for the mixers. Kenwood announced that it plans to play all mixers from the forward tees, while allowing anyone to move back to the middle tees with an additional 2 strokes added to their handicaps. There was agreement to experiment this year, and no policy was proposed at this time.

23 reps stayed to play golf after the meeting. We agreed to play from the forward tees (5452 yards) as an experiment. Everyone found it an enjoyable experience playing from the forward tees.

Manor Country Club will again be its annual holiday party in mid-December.

The fall meeting has not yet been scheduled.

Membership Committee Report Hobbits Glen Country Club March 20, 2012

An examination of the Associate Chairman's year end report reveals that we have a gain of 14 clubs since 2004. The problem is that we also show a loss of 644 members or 15% during the same period. This is a loss of 80 members per year.

To start the year 2012 we have a loss of 4 clubs, Nassawango, VFW, Ft. Meade and Hunters Oak. The membership of Ft. Meade, for the most part, will be moving to Compass Point, a new club for 2012. We also know that most of the members of the fallen clubs will be moving to other clubs in their area. However, we can expect a small loss in the transfers.

Unfortunately, we have an additional two clubs who also appear to be in trouble:

Wakefield Valley in Division II Elks Club in Division V

Cross Creek is still on probation pending their meeting the 32 member requirement. It is expected they will meet this goal in 2012.
