For many years MISGA has been returning to Carroll Valley Resort in September and 2010 is no exception. There are three different plans and you are free to pick the one of your choice.

Plan A is for the 18 hole golfer. It includes Green fees and cart, a banquet consisting of Hors D'oeuvres, Filet Mignon, Caesar salad, green beans, twice baked potatoes, ice cream and of course lodging on the 15th; breakfast and lunch on the 16th and prizes each day. All of this for only **\$238.00** per person.*

Plan B is for the 9 hole golfer or the non-golfer. It includes everything listed for the 18 hole golfer, except it does not include golf. 9 hole golfers will have to pay the golf fee (\$23.00) at the pro shop. They should also enter their 9 hole handicap index on the entry form. The fee for this package is **\$135.00** per person.

Plan C is for the local 18 hole golfer who does not want to stay at the hotel. It includes everything in plan A except lodging and breakfast. The fee for this package is **\$155.00** per person.

*Persons wishing to room by themselves should add \$63.00 to the above price.
