NORBECK COUNTRY CLUB - THURSDAY - SEPTEMBER 9, 2021
ROCKVILLE, MD (Rain Date: Wednesday - October 13, 2021)

FORMAT: 18-HOLE - TEAM STROKE PLAY (Gross & Net Best Ball)

The maximum field of 50 teams will not be divided into flights. Each 2-Player Team will be competing against all other 2-Player Teams. There will be one **Gross** and one **Net 2-Player Team Grand Champion**. **Scoring** = the sum of the teammates' lowest **gross** score on each hole and the sum of teammates' lowest **net** score on each hole.



ELIGIBILITY:

All MISGA associates in good standing. Finalists must qualify through their Division's selection process. Finalists must have an established valid USGA Handicap Index computed and maintained at the finalist's home club. Teammates of each 2-Player Team must be members of the same club. The 2019 Gross and Net 2-Player Team Grand Champions are automatically eligible (do not have to process through their Division's qualification process), but must pay the Entry Fee. **All participants must be fully vaccinated against the Covid-19.**

HANDICAP ALLOWANCE:

Tournament Playing Handicap = 85% of Course Handicap (men & women)

TEE PLACEMENTS:

(1) USGA Rules of Handicapping, Rule 6, Principle: Playing Handicap is calculated by applying the appropriate handicap allowance to a player's Course Handicap. **Appendix C: Handicap Allowances:** Stroke play, four-ball = 85%.
(2) Application of Rule 6.2b (i): As there is no difference in par between the gold and red tees, no additional strokes will be added to the women's Playing Handicap.

PRIZES:

1. Based on a full field of 50 teams, 16 total teams (32%) will receive a Pro Shop Gift Certificate (the Gross and Net Grand Champions plus 7 gross teams and 7 net teams).
2. In addition, the **Gross** and **Net Grand Champions** will receive a high quality engraved trophy.
3. Winners of the four *Closest-to-the-Pin* holes will receive a box of golf balls (12 count).



ENTRY FEE: (Instructions for the Division Tournament Chairmen)

1. The **Entry Fee - \$190 per team (\$95 per person)** - includes a buffet breakfast, range balls, cart fee, cash bar cocktail hour (w/light hors d'oeuvres), buffet dinner and prize pool.
2. Please submit **one check** for your Division's entrants. If space is available, your alternates will pay at the time of registration.

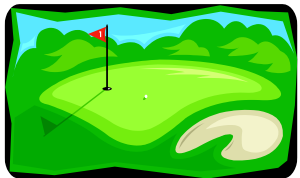

PRACTICE ROUNDS:

Practice rounds are permitted. Finalists must have their home Head Pro contact Norbeck CC Head Pro **Mike Barillo** (refer above) for arrangements to play at Norbeck CC.

TIE BREAKING PROCEDURE:

The tie breaking procedure for the **Gross** and **Net Grand Champions** will be a sudden-death playoff. All other places will be based on a match-of-cards for both the **Low Gross** and **Low Net** winners. The initial tie-breaker will be the best score attained for the last nine holes (10-18), then the last six holes (13-18), then the last three holes (16-18) and finally the 18th hole. Should a tie still exist, the match will be a hole-by-hole match beginning with the #1 handicap hole and proceeding to the #2 handicap hole and so on until the tie is broken.

TOURNAMENT COMMITTEE:

The **Tournament Committee** will include the **Division IV Director (Committee Chairman)**, the **Division IV Tournament Chairman**, the Norbeck CC **MISGA Club Rep**, the Norbeck CC **Head Pro** and such other individuals as may be designated by the Division IV Director. The MISGA Tournament Chairman will assist as needed.

The **Tournament Committee** will be responsible for establishing the conditions of competition; assuring adherence to USGA, MISGA and local rules of golf; assuring fairness of play and good sportsmanship; interpreting USGA, MISGA and local rules of play; answering technical questions; mediating disputes and resolving other issues and problems as they may occur.

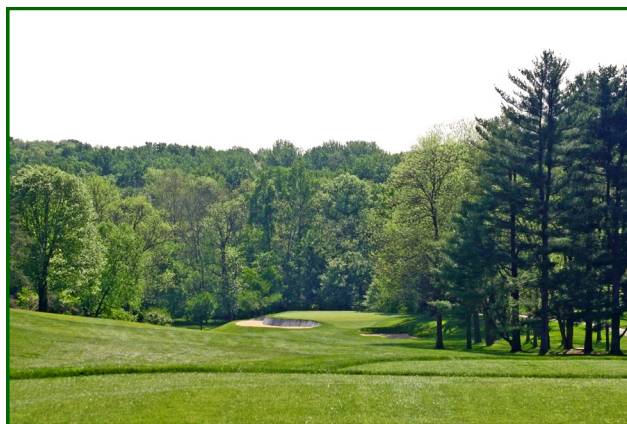

DIRECTIONS: *(If available, use your auto's GPS navigation system)*

From Frederick, MD, follow I-270 south to I-370 (Exit 9A). Turn left (east) onto I-370 and continue. The road will become the Inter-County Connector (Rt. #200). Continue on the ICC to Exit 8 - Georgia Avenue (Rt. #97). Turn left onto Georgia Ave. heading north toward Olney. Turn left (west) at the first traffic light onto Emory Lane and continue to Cashell Road. Turn right onto Cashell Road and continue to the entrance (on left) into Norbeck CC.

From Westminster, MD, follow Route #97 (Georgia Avenue) south to Hines Road. Turn right (west) onto Hines Road and continue to its end at Cashell Road. Turn left (south) onto Cashell Road and continue to the entrance (on right) into Norbeck CC.

From Baltimore, MD, follow I-95 south just past West Laurel, MD to Exit 31 - Inter-County Connector (Rt. #200). Turn right onto the ICC and continue west to Exit 8 - Georgia Avenue (Rt. #97). Turn right onto Georgia Ave. heading north toward Olney. Turn left at the first traffic light onto Emory Lane and continue to Cashell Road. Turn right onto Cashell Road and continue to the entrance (on left) into Norbeck CC.

From Eastern Shore, MD, follow Route 50 to the Washington Beltway (I-495). Turn right (north) onto Beltway and continue to I-95. Turn right (north) onto I-95 and continue to Exit 31 - Inter-County Connector (Rt. #200). Turn left onto the ICC and continue west to Exit 8 - Georgia Avenue (Rt. #97). Turn right onto Georgia Ave. heading north toward Olney. Turn left at the first traffic light onto Emory Lane and continue to Cashell Road. Turn right onto Cashell Road and continue to the entrance (on left) into Norbeck CC.

NOTE: The Inter-County Connector (ICC) is an uninterrupted signal free toll road. There are no toll booths - only EZ Pass detectors and cameras - hence, you cannot pay the toll fee by cash or credit card (approx. \$2.10 one way). If you do not have an EZ Pass, you will receive a bill in the mail (USPS). Also, if you do not have an EZ Pass, the toll fee will be a bit higher (admin costs).
