FORMAT: 18-HOLE - INDIVIDUAL STROKE PLAY (Gross & Net)

A maximum field of 100 competitors will be divided into four flights of A-B-C-D handicapped players - lowest in "A" to highest in "D" (approximately 25% in each flight). "A" players will compete against "A" players, "B" players against "B" players, "C" players against "Cs" and "Ds" against "Ds." The **Gross** and **Net Grand Champions** can come from any of the four flights.

ELIGIBILITY:

All MISGA associates in good standing. Finalists must qualify through their Division's selection process. Each finalist must have an established valid USGA Handicap Index computed and maintained at the finalist's home club. The current MISGA President, all MISGA Past Presidents and the 2019 Gross and Net Past Presidents (ABCD) Grand Champions are automatically eligible (they do not have to process through their Division's qualification procedure), but must pay the Entry Fee. **All participants must be fully vaccinated against the Covid-19.**

HANDICAP ALLOWANCE:

Tournament Playing Handicap = **95%** of **Course Handicap** (men & women)

- (1) USGA Rules of Handicapping, Rule 6, Principle: Playing Handicap is calculated by applying the appropriate handicap allowance to a player's Course Handicap. Appendix C: Handicap Allowances: Stroke play, individual = 95%.
- (2) Application of Rule 6.2b (i): As there is a one stroke difference in par between the green and red tees, one additional stroke will be added to the women's Playing Handicap.

PRIZES:

1. Based on a full field of 100 finalists, 26 winners will receive a Pro Shop Gift Certificate (the Gross and Net Grand Champions plus 3 gross and 3 net winners in each flight).
2. In addition, the **Gross** and **Net Grand Champions** will receive a high quality engraved trophy.
3. Winners of the four *Closest-to-the-Pin* holes will receive a cash prize - split the pot. \$5 entry fee.

ENTRY FEE: *(Instructions for the Division Tournament Chairmen)*

1. The **Entry Fee - \$95 per person** - includes a buffet breakfast, range balls, cart fee, post-golf cash bar cocktail hour (*w/light hors d'oeuvres*), buffet dinner and prize pool.
2. Please submit **one check** for your Division's entrants. If space is available, your alternates will pay at the time of registration.

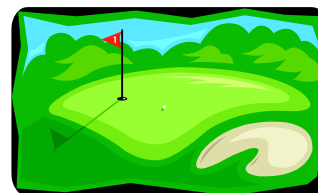

PRACTICE ROUNDS:

Practice rounds are permitted. Qualified finalists only - contact Director of Golf James Starnes (refer above). \$35 - Tuesdays & Thursdays after 12 noon.

TIE BREAKING PROCEDURE:

The tie breaking procedure for the **Gross** and **Net Grand Champions** will be a sudden-death playoff. All other places will be based on a match-of-cards for both the *Low Gross* and *Low Net* winners. The initial tie-breaker will be the best score attained for the last nine holes (10-18), then the last six holes (13-18), then the last three holes (16-18) and finally the 18th hole. Should a tie still exist, the match will be a hole-by-hole match beginning with the #1 handicap hole and proceeding to the #2 handicap hole and so on until the tie is broken.

TOURNAMENT COMMITTEE:

The **Tournament Committee** will include the **Division II Director (Committee Chairman)**, the **Division II Tournament Chairman**, the Holly Hills CC **MISGA Club Rep**, the Holly Hills CC **Head Pro** and such other individuals as may be designated by the Division II Director. The MISGA Tournament Chairman will assist as needed.

The **Tournament Committee** will be responsible for establishing the conditions of competition; assuring adherence to USGA, MISGA and local rules of golf; assuring fairness of play and good sportsmanship; interpreting USGA, MISGA and local rules of play; answering technical questions; mediating disputes and resolving other issues and problems as they may occur.

DIRECTIONS: *(If available, use your auto's GPS navigation system)*

From the Washington, DC area

1. From **north** or **south** of DC, follow the Capital Beltway (I-495) to either Exit 35 (from south of DC) or Exit 38 (from north of DC). Turn onto I-270 and head west toward Frederick. At Exit 26 (Urbana), turn right onto Rt. #80 and drive through Urbana heading north-east for approximately 2 miles to Ijamsville Road. Turn left onto Ijamsville Road. After about 1 mile, you will cross a narrow 2 lane bridge. After crossing the bridge continue straight onto Mussetter Road (Ijamsville Road goes left). Continue on Mussetter Road for approximately 2 miles to Ritchie Drive. You will see a sign for Holly Hills CC. Turn left onto Ritchie Road and continue to another HHCC sign. Turn left and up the hill to the Clubhouse parking lot.
2. From **east** or **south** of DC, follow the Capital Beltway (I-495) to Exit 22 onto the Baltimore-Washington Parkway (I-295). Head north on the BW Parkway to Rt. 32. Turn left onto Rt. #32 and head west to I-70. Turn left onto I-70 and head west to Exit 62 (Rt.#75). Turn right onto Rt. #75 (toward Libertytown), but make an immediate left turn at the intersection and head toward and through New Market. About 1 mile past New Market turn left onto Mussetter Road. Just after crossing I-70, you will see a sign to Holly Hills CC. Turn right onto Ritchie Drive and continue to another HHCC sign. Turn left and up the hill to the Clubhouse.

From Hagerstown area

Take I-70 east through **Frederick** to Exit 56 (East Patrick Street). Turn left onto Rt. 144 and head east for approximately 3 miles to Ijamsville Road. Turn right onto Ijamsville Road to Ritchie Drive. Turn left onto Ritchie Drive and continue to the Holly Hills CC sign. Turn right and up the hill to the Clubhouse parking lot.

From Westminster area

From Westminster, follow Rt. #27 south to I-70. At Exit 68, turn right onto I-70 and head west toward Frederick. At Exit 62, turn right onto Rt. #75 (toward Libertytown), but make an immediate left turn at the intersection and head toward and through New Market. About 1 mile past New Market turn left onto Mussetter Road. Just after crossing I-70 you will see a sign to Holly Hills CC. Turn right onto Ritchie Road and continue to another HHCC sign. Turn left and drive up the hill to the Clubhouse parking lot.

From Eastern Shore - follow Route 50 west across the Chesapeake Bay Bridge to:

1. Exit 27. Turn right onto Rt. #2 and head north to Rt. #100. Turn left onto Rt. #100 and head west to Rt. #29. Turn right onto Rt. #29 and head north to I-70. Turn left onto I-70 and head west to Exit 62 (Rt. #75) Turn right onto Rt. #75 (toward Libertytown), but make an immediate left turn at the intersection and head toward and through New Market. About 1 mile past New Market turn left onto Mussetter Road. Just after crossing I-70, you will see a sign to Holly Hills CC. Turn right onto Ritchie Drive and continue to another HHCC sign. Turn left and up the hill to the Clubhouse parking lot.
2. Exit 21. Turn right onto I-97 and head north to Rt. #32. Turn left onto Rt. #32 and head west to I-70. Turn left onto I-70 and head west to Exit 62 (Rt. #75). Turn right onto Rt. #75 (toward Libertytown), but make an immediate left turn at the intersection and head toward and through New Market. About 1 mile past New Market turn left onto Mussetter Road. Just after crossing I-70, you will see a sign to Holly Hills CC. Turn right onto Ritchie Drive and continue to another HHCC sign. Turn left and up the hill to the Clubhouse parking lot.
